

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.**
- 2. Eligibility:** "Grab The Tab" (the "Contest") is open only to Eligible Schools that sign up by their authorized agent(s) on the contest page located at www.zzgrabthetab.com. Detailed definition of Eligible Schools are specified below. Employees of National Food Group, Inc., a Michigan corporation (the "Sponsor") its respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest.  - b.** The phrase "students typically attend full-time" does not mean that all students must attend the school full-time for the institution to be eligible to participate in the Contest. It only means that the institution must offer a full-time program and that most of its students must attend full-time.
 - c.** If a private school has separate campuses for a lower school, possibly a middle school, and an upper school, and the schools are run as a cohesive whole with the same name, and students typically automatically advance from one campus to the next (unless they are removed by their parents/guardians), then the school will be treated as a single school for the Contest eligibility purposes.
 - d.** If a high school has a separate campus for ninth-graders, possibly with a partly separate administration, but is generally run cohesively and under a single name, then the ninth-grade campus will not be considered a separate school; rather, the ninth- through (usually) twelfth-grade campus will all be considered to attend, and be eligible to play for, the same school. This only applies to schools with a separate campus exclusively for ninth-graders; it does not apply to other ways of splitting grades across campuses.

Official Rules



- 5. Contest Period:** Entries will be accepted online starting on or about **March 11, 2024** and ending **March 22, 2024**. All online entries must be received by March 22, 2024 at 11:59PM EST.
- 6. How to Enter:** The Contest must be entered by submitting an entry using the online form provided on this Contest site, located at www.zzgrabthetab.com. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor.
